Note: A revised process has been implemented regarding candidate application for membership in CSE. Included are the Candidate Application Process, the Application for New Membership form. The Application Form should be completed after a candidate has finished the required instruction offered by the Ministerial Council on the philosophy, science and religion of Modern Spiritualism.

CSE MEMBERSHIP

CANDIDATE APPLICATION PROCESS

- 1.** Candidate makes inquiry regarding CSE membership.
- 2.** A Candidate Sponsor is designated. The Sponsor serves as an advisor to the Candidate, answering questions, and referring the Candidate to appropriate Board Members and the Ministerial Council for further information.
- 3.** Candidate discusses membership orientation requirements with the Pastor or Assistant Pastor and participates in recommended classes (Member Orientation Classes held at the Church, evening CSE classes, or other available equivalent instruction).
- 4.** Upon conclusion of class requirements, candidate completes the Application for New Membership Form (Form attached), writes a check appropriate for the time of year in which the application is filed (payable to The Center for Spiritual Enlightenment), and gives the application and check to the Pastor, Assistant Pastor, any Board Member, or the Membership Chair.
- 5.** The application form is forwarded to the CSE Board for review and action.
- 6.** Upon approval of application, Membership sends a letter of Welcome on behalf of the Membership and the Board, and ensures that a copy of the application and the check are mailed or given to the Board Treasurer. The Membership Card is included as an attachment to the letter.
- 7.** The Ministerial Council schedules the Right Hand of Fellowship Ceremony, notifying the Candidate, the Board and the Candidate Sponsor of date and time. The Ceremony is conducted as a formal induction to Center for Spiritual Enlightenment membership.

- ☼ When above step is completed, submit the Application for New Membership Form with a check for the appropriate amount (see Membership Fees below)*, payable to the Center for Spiritual Enlightenment. Give the Form to the Pastor, Rev. Anne Gehman, Assistant Pastor, Rev. Patricia Stranahan, or any Board Member. Alternative: Mail Form and check to CSE Membership. (address below).

Upon receipt of the Application Form, the Board of Directors will review your Application at their next scheduled Board meeting and vote on your admission to the Center for Spiritual Enlightenment membership. You will be notified shortly thereafter.
